1. Who We Are

We are the data controller responsible for your personal data under UK data protection laws, including the UK General Data Protection Regulation (UK GDPR) and the Data Protection Act 2018.

2. What Data We Collect

We collect and process personal information that is necessary for us to operate our business and provide auction services. This includes:

- Identity Data: your name, title, date of birth (if applicable), and username.
- Contact Data: billing address, delivery address, email address, and telephone numbers.
- Financial Data: payment details, such as card details or bank account information (processed securely via third-party providers).
 - Transaction Data: details about payments to and from you, and purchases or bids you make.
- Technical Data: IP address, browser type and version, time zone setting, operating system, and other technical information collected via cookies or analytics.
- Marketing and Communications Data: your preferences in receiving marketing communications from us.

3. How We Collect Your Data

We collect personal data in several ways:

- When you register to bid or sell with us (online, in person, or via telephone).
- When you contact us by phone, email, or through our websites.
- When you use our online bidding platforms, including our own platform and third-party sites such as The Saleroom.
- Through cookies and tracking tools, including Google Analytics and the Meta Pixel (Facebook and Instagram), when you browse our websites.

4. How We Use Your Data

We use your personal information for the following purposes:

- To register you as a buyer or seller.
- To process bids, payments, and deliveries.
- To manage your account and provide customer service.

- To communicate with you regarding upcoming sales, auctions, and items of interest.
- To send newsletters and marketing materials (you agree to receive these when accepting our Terms & Conditions, though you can unsubscribe at any time).
- To deliver and measure the effectiveness of digital advertising campaigns, including retargeting on Facebook and Instagram.
 - To comply with legal obligations, including anti-money-laundering checks where required.
 - To improve our website, services, and user experience.

5. Legal Basis for Processing

We rely on the following legal grounds under UK GDPR:

- Contractual necessity: to fulfil our obligations to you when you register, bid, or sell with us.
- Legitimate interests: to operate and improve our business and maintain customer relationships.
- Legal obligations: to comply with financial, tax, or anti-fraud regulations.
- Consent: for marketing emails, cookies, and retargeting advertising (which you may withdraw at any time).

6. Sharing Your Data

We only share your personal data where necessary and appropriate, including:

- The Saleroom (ATG Media) for participation in our online auctions.
- Mailchimp to send newsletters and marketing emails.
- HubSpot for customer relationship management and communications.
- Meta (Facebook and Instagram) for advertising and retargeting using the Meta Pixel and Custom Audiences. We may share limited, encrypted data (such as your email address) with Meta to help show relevant ads. Meta may use this information in accordance with its Data Policy (https://www.facebook.com/policy.php).
 - Payment processors and banks for secure handling of financial transactions.
 - Delivery couriers or logistics providers for shipping purchased items.
 - Professional advisors and legal authorities where required by law or regulation.

We do not sell your personal information to third parties.

7. Cookies and Analytics

We use cookies and similar technologies to enhance your browsing experience and analyse site performance.

This includes Google Analytics, Meta Pixel, and other tracking tools that help us understand visitor behaviour and advertising performance.

You can manage or disable cookies through your browser settings. For more information, see our Cookie Policy (https://bespokeauctions.co.uk/cookie-policy).

8. International Transfers

While we are based in the UK, we may occasionally transfer data outside the UK (for example, through Mailchimp, HubSpot, or Meta).

In such cases, we ensure your data is protected under approved safeguards, such as UK adequacy decisions or standard contractual clauses.

9. Data Retention

We retain personal data only as long as necessary for the purposes described above, including to comply with legal and accounting requirements.

Typically:

- Customer and transaction data are retained for up to 7 years for tax and legal purposes.
- Marketing data is kept until you unsubscribe or request deletion.

10. Your Rights

Under UK data protection law, you have the right to:

- Request access to your personal data.
- Request correction of inaccurate or incomplete data.
- Request deletion of your data ("right to be forgotten").
- Object to or restrict processing in certain circumstances.
- Withdraw consent for marketing communications at any time.

1. What Are Cookies?

2. How We Use Cookies

We use cookies to:

- Performance & Analytics Cookies Purpose: Help us understand how visitors use our websites so we can improve them. Example: Google Analytics
- Functionality Cookies Purpose: Allow us to remember your preferences and settings. Example: Language or region settings
- Marketing & Advertising Cookies Purpose: Used to deliver relevant advertising or limit the number of times you see an ad. Example: Meta Pixel, Mailchimp tracking cookies, HubSpot analytics

4. Third-Party Cookies

Some cookies are set by third parties that provide services to us, such as:

- Google Analytics to collect anonymous information about how visitors use our site.
- Mailchimp to track newsletter engagement and measure performance.
- HubSpot for customer engagement and site analytics.
- Meta (Facebook and Instagram) to measure website activity and deliver relevant advertisements on Facebook and Instagram.
 - The Saleroom (ATG Media) when bidding or registering through their platform.

These third parties may use cookies according to their own privacy policies.
